**The MERA Bylaws, in summary, set forth the following requirements for membership eligibility:**

**REMANUFACTURER MEMBER:** A company which conducts business in the remanufacturing industry, primarily in the remanufacture of *products* in North America.

**SUPPLIER MEMBER:** A company engaged primarily in one or more of the following activities in the remanufacturing industry: (1) purchase, sale, or trade of cores; (2) provision of parts or materials (e.g., seals, gaskets, electronics, plastics); (3) provision of product engineering, design, testing, and prototyping services; and (4) provision of machinery, tools, dies, and molds.

**AFFILIATE MEMBER:** A company not eligible for membership as a remanufacturer or supplier member, but provides products and/or services to the remanufacturing industry.

**ASSOCIATE MEMBER:** A company not eligible for membership as a remanufacturer or supplier member, but can be classified as one of the following: (1) publishing/media company, (2) educational institution, (3) industry affiliate group, or (4) small consultancy with five or fewer employees.

**MEMBERSHIP DUES: (in U.S. Dollars)**

Check the box below that is appropriate for your company. Note: Remanufacturer membership dues are based on North American annual sales volume. Supplier membership dues are based on overall sales. Membership dues for Affiliate and Associate members are not dependent on sales volume.
